COURSE LEARNING OUTCOMES

Upon completion of this course, the students will be able to:

- use a correct vocal technique;
- apply correctly they know-how and technical skills to the repertoire covered in class;
- keep a correct breathing and posture in order to sing;
- perform correctly in different styles within the field of jazz and modern music;
- recognise and sing the different modes of the major scale;
- apply vocal improvisation tools to the repertoire covered in class, starting from bass lines, arpeggios and guide notes. Use the major scale modes following the relation between scale and chord;
- recognise and sing the intervals and arpeggios demanded in the corresponding level;
- formally and structurally analyse music pieces from the jazz and blues repertoire;
- transcribe and perform vocal or instrumental solos integrating the resources learnt;
- recognise simple harmonic progressions;
- analyse, recognise and incorporate specific stylistic resources from referential singers or instrumentalists within the field of jazz and modern music;
- develop a personal performing style;

- create a simple arrangement, providing personal ideas and keeping the essence of the original composition;
- sing simple melodies at first-sight.

I. Scales	Theme 1. Modes of the major scale
	Theme 2. Chord scales: lidiab7, mixolidiab13, mixolidiab9b13, altered
	Theme 3. Intervallic exercises in all the studied scales: 3 rd , 4 th , 5 th , 6 th , 7 th and 8 th .
II. Arpeggios	Theme 4. Triads (all inversions): major, minor, augmented, diminished, sus4.
	Theme 5. Four-part chords: maj7, m7, m7b5, dim7, 7, 7sus4, m6 in two octaves in 8th notes. Minimum quarter note = 120 bpm.
	Theme 6 Arpeggios sequences by circles of fifths, descending
III. Arpeggios and guide notes in basic harmonic progressions	Theme 7. Minor and major cliché lines (all the keys).
	Theme 8. Jazz blues, rhythm changes (all the keys).
IV. Repertoire performance	Theme 9. Performance of the jazz repertoire and other related styles, applying the technical, rhythmic, stylistic and expressive resources in each case.
V. Improvisation	Theme 10. Work based on bass lines, arpeggios and guide notes. Use of modes of the major scales. Delivery of a harmonic scheme of (At least) two of the themes covered in class in order to use them as study material, including bass lines, arpeggios and guide tones. Improvisation over <i>rhythm changes</i> .
VI. Reading	Theme 11. Singing at first sight of melodies in simple keys including intervallic jumps of 3rds, 4ths, 5ths, 6ths, 7ths.
VII. Ear training applied to the instrument	Theme 12. Recognition and practice of intervals, arpeggios and scales.
VIII. Concepts	Theme 13. Concepts proposed by the instructor or suggested by the students according to their interests.
IX. Styles	Theme 14. Practice in different styles.
X. Personal sound research	Theme 15. Tutorial classes focused on research and development of the student personal style.

METHODOLOGY

Theoretical activities	Theoretical/conceptual explanations and analysis of different examples coming from all the most relevant music styles.
Practical activities	Practical application of what has been studied in class through transcriptions, collective group intonation, performance with instrument, sight-reading, rhythms composition.
Other training mandatory activities (workshops, seminars, etc.)	Attend and participate in the events considered relevant for their training (Meet the Artists sessions, concerts, rehearsals etc.).
